2. Cost:

The total cost of the funeral goods and services and non-funeral establishment charges listed on the attached Statement of Funeral Goods and Services will be R12 000.00 ("Total Cost").

3. Funding Method:

Buyer will pay the cost for the funeral goods and services of Licenced Funeral Establishment Charges in the following way:

Fully fund this Agreement; Buyer will pay R12 000.00 upon entering into this Agreement.

4. Cost Protection:

Is cost-protected with respect to goods and services provided by the Licensed Funeral Establishment upon receipt of payment to fully fund this agreement, and is cost protected with respect to Funeral Establishment charges for goods and services to be provided Funeral Establishment.

5. Revocable or Irrevocable (see paragraph 6)

6. Termination

Revocable: This Agreement can be terminated by Buyer without penalty within ten (10) days of the date first set forth below

After 10 days (d) If this Agreement is irrevocable, this Agreement may not be cancelled after ten (10) days by either party, except by order of a court of competent jurisdiction.
